BIOGRAPHICAL INFORMATION/ORGANIZATION HISTORY

In November 1937 Stamford resident, Wolfgang Jung, purchased 178 acres of property between Georges Hill and Peter Roads in Southbury. Jung, in collaboration with German Nazi, Fritz Kuhn and his American Nazi organization, the German American Bund, intended to construct a Nazi youth training camp on the property. Many community leaders and Southbury residents banded together in an anti-Bund movement and, utilizing Connecticut's Blue Laws, created town zoning laws that led to the arrest of two "Bundists" and the eventual removal of Kuhn and the remaining Bund members in December 1937.

SCOPE & CONTENT NOTE

Artificial collection of material pertaining to the Nazi Bund and its relationship to, and eventual expulsion from, Southbury. Dates for the collection currently range from 1935 – 2016, with the bulk of material from 1937. The collection is textual, consisting mostly of newspaper articles, correspondence, journals, and some legal documents. There is some digital media in the form of DVDs in Subseries 1.12, 1.16, and Series 2. The only photographs are in newspaper articles.

Of particular interest: signed letter from Fritz Kuhn, box 1, folder 15; German-American Bund application, box 1, folder 17; copies of warrants against two "Bundists", box 1, folder 21; Southbury Zoning Regulations, box 2, folder 8; Special Town Meeting notice and minutes, box 2, folder 17; two versions of the *Home of the Brave* documentary, box 2, folder 23; and Rev. M.E.N Lindsay's 1937 anti-Nazi sermon, box 2, folder 25.

SYSTEM OF ARRANGEMENT

The Bund Collection is arranged in two Series. In Series 1 donors or sources are identified and include the accession number or donation receipt number (for early donations) in parenthesis. Each Subseries under Series 1 constitutes an individual donation or provenance. Series 2 consists of material from unidentified collections or sources and is not divided into subseries. Please note that the oversized newspapers in Series 2 are housed in Map Case Drawer 6. Correspondence and newspaper articles are arranged chronologically with the earliest date first. ND = No Date and [Date] = Approximate or best estimate of date.
